## PILGRIMAGE TERMS AND CONDITIONS

Poland-Medjugorje Pilgrimage LLC is only responsible for mailing your round trip airline ticket from Toronto (depending on the airline schedule), air conditioned Deluxe Motor Coach Transportation to other destinations, providing overnight accommodations (double occupancy), and two meals daily. If a single room is desired, the additional cost will be \$600. You will be responsible for your personal expenses. Every individual participating in this pilgrimage is responsible for arriving on time for the flight. Poland-Medjugorje Pilgrimage LLC, its officers and employees are not responsible for any arrangements or additional expenses necessary in the event any individual misses a flight in Canada or Europe. Each individual is also responsible to arrive on time for the bus. If you miss the bus, it is your responsibility to meet the group, wherever we are, at your own expense.

**PASSENGER NAME:** Passengers are responsible to ensure that the name printed on the pilgrimage letter exactly match the first and last name as it appears on their passport. Due to security requirements, any name change, including minor spelling corrections, may require airline reservations to be cancelled and rebooked. Poland -Medjugorje Pilgrimage LLC will not be held liable for denial of services by an airline carrier due to any name discrepancy.

**TOUR CANCELLATION BY OPERATOR:** Poland-Medjugorje Pilgrimage LLC assumes no liability for conjunction tickets, non-refundable or otherwise or cancellations due to state travel advisories and/or state travel warnings, Acts of War, War, Terrorism, Acts of God, Natural Disaster or any other circumstance outside the control of Poland-Medjugorje Pilgrimage LLC. Cancellation for any of these reasons will not be eligible for any form of refund.

**PHYSICAL DISABILITIES:** Any disability requiring special attention must be noted on the Reservation Form. Any person who cannot travel independently or who needs physical assistance of any kind, must be accompanied by a companion who can fully and solely attend to the person's needs. Our guides and drivers cannot help a handicapped person, nor can we ask our staff or the pilgrims to help. We are really not equipped to handle Handicapped pilgrims. We are also not equipped to handle special diet meals. The pilgrim must take care of any special needs directly with airlines, hotels or bus himself. Poland-Medjugorje Pilgrimage LLC hereby reserves the right to refuse to allow travel with its group to any individual who appears medically unfit to participate on the pilgrimage due to infirmity or illness. Individuals who may have recently undergone surgery, incurred an injury or are otherwise in need of special assistance to deal with a disability, are encouraged to fully discuss these issues in advance of their scheduled departure to determine if they should come on the trip and also as may be appropriate, to obtain a physicians letter stating that the individual is medically fit to travel and participate in the pilgrimage.

Anyone who is refused travel for this reason will not be eligible for any form of refund and it will be the individuals responsibility to make travel arrangements to return home.

**REFUND POLICY/TRAVEL INSURANCE:** **All cancellations or refunds must be made in writing.** There will be a \$300 penalty for cancellations made up to 60 days prior to departure. Less than 60 days prior to departure no refunds will be made. Therefore, IT IS HIGHLY RECOMMENDED THAT YOU PURCHASE TRAVEL INSURANCE. Please direct any questions regarding insurance coverage to CSA. CSA Travel Protection specializes in Travel Insurance outside of the United States. If you decide to purchase insurance from another company make sure they cover you outside of Canada. **In order to participate in this pilgrimage you must have your own insurance which will cover you in case of sickness or accident while you are outside of Canada.**

**ILLNESS OR INJURY:** In case of illness or injury Poland-Medjugorje Pilgrimage LLC will provide transportation to a hospital. If a hospital stay is required the family is then responsible for the care and return trip to Canada of the sick or injured party. Poland-Medjugorje Pilgrimage LLC, its officers and employees cannot be held liable for any injuries, delays, loss of luggage, health issues, damages and/or any accidents that may occur on this trip.

Each pilgrim **must** be able to walk at least two (2) miles a day. In many European cities the streets are very narrow and cobble stoned and the buses must drop the pilgrims off at a distance from the churches and other places we will be visiting.

**MEALS:** Poland-Medjugorje Pilgrimage LLC provides two meals per day; breakfast and dinner. Beverages served with the evening meal are not included. No refunds for uneaten meals.

**LUGGAGE:** Poland-Medjugorje Pilgrimage LLC is not liable for the loss of, theft of, delay, or damage to a participant's belongings. Since most of our travel is by bus and space for luggage is limited on the bus, it is highly recommended that each individual bring only what is absolutely necessary. **Each tour participant is allowed to bring one suitcase and one small overnight bag (9" x 14" x 22").**

**DOCUMENTS:** **A valid Canadian Passport valid for at least 6 months from the date of return of your trip is required for travel.** If you arrive at the airport without the necessary papers, you will not be allowed to continue on the trip. It will then be your responsibility to get the necessary papers and join the group wherever we are, at your own expense.

**LIABILITY:** It is hereby agreed that any and all claims, disputes or controversies whatsoever arising from, related to, or in connection with these Terms and Conditions shall be commenced, filed and litigated, if at all, before the United States District Court for the District of Connecticut in Hartford, Connecticut, or as to those law suits to which the Federal Courts of the United States lack subject matter Jurisdiction, before a court located in Hartford, Connecticut, U.S.A., to the exclusion of the Courts of any other country, state, city or county.
